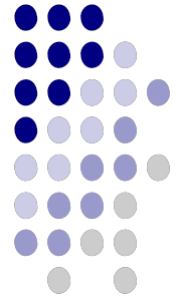




POLITIKA OKOLINSKOG UPRAVLJANJA
